1. Leyburn Town Council ("the Council") hereby invites tenders for the carrying out of the Service of Grass Cutting and maintenance in accordance with the Contract documents attached, which comprise:

  - I. EVALUATION
2. The Prices submitted must indicate the rate for carrying out each element of the Contract.
3. Prospective Contractors should ensure that they are completely familiar with the nature and extent of the obligations to be accepted by them, if their tender is accepted.
4. Any queries regarding the interpretation of any part of the Contract documents should be addressed to the Officer by **no later than two weeks before the closing date.**
5. The tender shall be submitted ONLY on the attached Form of Tender.
6. The Council is under no obligation to consider any clarifications / amendments to the Contract proposed following the Clarification Deadline, but before the Tender Response Deadline (as defined below in the Timescales section of this ITT). Any proposed amendments that received from a potential supplier as part of its tender response may entitle the Council to reject that tender response and to disqualify that potential supplier from this Procurement Process.

7. Prospective Contractors should note that the Council is not bound to accept the lowest, or any tender.
8. **The Council's decision is final and no correspondence will be entered into on the reasons why a tender has been rejected.**
9. The successful tender together with the Council's written acceptance shall form a binding agreement in the terms of the Contract documents. The Council's contracting and commercial approach in respect of the required goods and/or services is set out at Appendix C Detailed Contract Specification (Terms and Conditions of contract) ("**Contract**"). By submitting a tender response, you are agreeing to be bound by the terms of this ITT and the Contract without further negotiation or amendment.
10. Your tender responses to the tender requirements and pricing will be incorporated into the Contract, as appropriate.

## Instructions for Responding

---

Before you submit your response, familiarise yourself with the tender documentation, and ensure that:

- You want to bid for this contract (you can deliver it, it is not too risky or costly)
- You can meet the deadlines for submission
- You have the resources you need, including staff

By submitting a response, you are committing to an understanding that you understand the requirement and have sufficiently addressed all aspects of the tender and information contained within the data room and that you have checked all stated details, such as prices, to be correct and as intended.

The Council reserves the right to issue any clarification request made by you, and the

If the Council considers the contents of the request not to be confidential, it will inform you and you will have the opportunity to withdraw the clarification query prior to the Council responding to all potential suppliers.

The Council may at any time request further information from potential suppliers to verify or clarify any aspects of their tender response or other information they may have provided. Should you not provide supplementary information or clarifications to the Council by any deadline notified to you, your tender response may be rejected in full and you may be disqualified from this Procurement Process.

## **B. STANDARD CONTRACT CONDITIONS**

---

This section sets out the Council’s contracting requirements, general policy requirements, and the general tender conditions relating to this procurement process (“Procurement Process”).

### **Officer**

---

The Officer will be the Town Clerk.

### **Contracting Authority**

---

The contracting authority is the Council, which includes any subsidiary companies and other organisations that control or are controlled by the Council from time to time.

### **Extent of Work**

---

The work will comprise of the cutting of grass and ground maintenance of the Shawl Playing Fields. **(Please see the Detailed Contract Specification, Schedule of works & the Site plans attached).**

**A regular inspection will be carried out by the Council throughout the period of the Contract to ensure the work is completed in accordance with the Specifications.**

### **Site Details**

---

The appointed supplier will be expected to deliver the goods and/or provide services at the locations detailed in the maps section of the specification.

### **Workmanship and Equipment**

---

The workmanship must be of the highest standard and shall conform to all relevant British Standards, Specifications and Codes of Practice.

### **Additional Erection/Installation**

---

The Council may at any time add or remove outside fixtures and fittings (play equipment, benches, planting etc.) during the period of the Contract and no application from the Contractor to adjust the contract price as a consequence will be considered.



## Duration of Contract

---

The duration of the Contract awarded will be three years commencing **1<sup>st</sup> April 2023 to 31<sup>st</sup> March 2026 inclusive, with annual performance reviews.**

Tenders are to be priced on a per cut basis. There will be no opportunity to alter the rates tendered during the full term of the contract.

## Payment to Contractor

---

The Council require invoicing “per cut” so invoices will be sent at the end of the month for work carried out that month.

The Contractor will submit a monthly invoice, **by the 10th of the following month for it to be paid before the end of that month, throughout the cutting season for all work carried out. Invoices submitted after the 10th of the month will not be paid until the following month unless the Officer has sufficient time to include them on the Town Council Agenda.**

The amount invoiced **must correspond to the prices quoted in the Priced Schedule.**

**Any additional hours for work not detailed within the contract will need to be approved by the Council and then a purchase order/ job sheet will be issued to the contractor.**

The Council may dispute any additional hours invoiced that hasn't been pre-approved by the Council.

The Council will pay correctly addressed and undisputed invoices within 30 days in accordance with the requirements of the Contract. Suppliers to the Council must ensure comparable payment provisions apply to the payment of their sub-contractors and the sub-contractors of their sub-contractors. General requirements for an invoice for the Council include:

- A description of the good/services supplied is included.
- The Council's reference number/Purchase Order number is included.
- It must be addressed to Leyburn Town Council and sent to [Clerk@Leyburntowncouncil.gov.uk](mailto:Clerk@Leyburntowncouncil.gov.uk) or by post to Leyburn Town Council, Thornborough Hall, Leyburn, North Yorkshire, DL8 5AB.

## Rights to cancel or vary this Procurement Process

---

By issuing this ITT, entering into clarification communications with potential suppliers or by having any other form of communication with potential suppliers, the Council is not bound in any way to enter into any contractual or other arrangement with you or any other potential supplier. It is intended that the remainder of this Procurement Process will take place in accordance with the provisions of this ITT but the Council reserves the right to terminate, suspend, amend or vary (to include, without limitation, in relation to any timescales or deadlines) this Procurement Process by notice to all potential supplier in writing. Subject to the “Liability” Tender Condition below, the Council will have no liability for any losses, costs or expenses caused to you as a result of such termination, suspension, amendment or variation.

## Termination of Contract

---

The Council reserves the right to terminate this contract within 30 days written notice if, in its opinion, the Contractor fails to meet the terms and conditions of the contract.

Either party may, without reason, terminate the Contract, in writing, giving no less than Three Months’ Notice.

## Insurance

---

The Contractor is required to have a minimum of £5,000,000 public liability insurance. A current Certificate of Insurance to this effect must be produced to the Officer prior to commencement of the Contract and annually thereafter.

The Contractor shall indemnify the Council against any claim or proceedings for any injury or damage to any property or persons or animals as a result of negligence, poor workmanship or failure to notify the Council of any action likely to cause injury or damage to a third party. Any damage caused to any property during the performance of this contract must be reported to the Officer immediately and any costs involved to rectify the damage will be the responsibility of the contractor.

## Liability

---

Nothing in these Tender Conditions is intended to exclude or limit the liability of the Council in relation to fraud or in other circumstances where the Council’s liability may not be limited under any applicable law.

## Consortium Members and Sub-Contractors

---

It is your responsibility to ensure that any staff, consortium members, sub-contractors and advisers abide by these Tender Conditions and the requirements of this ITT.

By submitting a tender response in connection with this Procurement Process, potential suppliers confirm that they will, and that they shall ensure that any consortium members and/or subcontractors will, comply with all applicable laws, codes of practice, statutory guidance and applicable Council policies relevant to the goods and/or services being supplied.

## Health and Safety

---

The Contractor shall comply with all relevant statutory requirements (including Health and Safety at Work Legislation) at all times in carrying out the services described in this agreement. All works will be carried out in accordance with the Safety at Street Works and Road Works: Code of Practice 2013.

## Confidentiality and Information Governance

---

All information supplied to you by the Council, including this ITT and all other documents relating to this Procurement Process, either in writing or orally, must be treated in confidence and not disclosed to any third party (save to your professional advisers, consortium members and/or sub-contractors strictly for the purposes only of helping you to participate in this Procurement Process and/or prepare your tender response) unless the information is already in the public domain or is required to be disclosed under any applicable laws.

You shall not disclose, copy or reproduce any of the information supplied to you as part of this Procurement Process other than for the purposes of preparing and submitting a tender response. There must be no publicity by you regarding the Procurement Process or the future award of any contract unless the Council has given express written consent to the relevant communication.

The Council reserves the right to disclose all documents relating to this Procurement Process, including without limitation your tender response, to any employee, third party agent, adviser or other third party involved in the procurement in support of, and/or in collaboration with, the Council. The Council further reserves the right to publish the

Contract once awarded and/or disclose information in connection with supplier performance under the Contract in accordance with any public sector transparency policies (as referred to below). By participating in this Procurement Process, you agree to such disclosure and/or publication by the Council in accordance with such rights reserved by it under this paragraph.

The Freedom of Information Act 2000 (“FOIA”), the Environmental Information Regulations 2004 (“EIR”), and public sector transparency policies, apply to the Council (together the “**Disclosure Obligations**”).

You should be aware of the Council’s obligations and responsibilities under the Disclosure Obligations to disclose information held by the Council. Information provided by you in connection with this Procurement Process, or with any contract that may be awarded as a result of this exercise, may therefore have to be disclosed by the Council under the Disclosure Obligations, unless the Council decides that one of the statutory exemptions under the FOIA or the EIR applies.

## Tender Validity

---

Your tender response must remain open for acceptance by the Council for a period of ninety days from the Tender Response Deadline. A tender response not valid for this period may be rejected by the Council.

## Notes to Tenderers (“General Tender Conditions”)

---

Attention is drawn to the Form of Tender and Standard Contract Conditions. These documents must be read in conjunction with the Specification of Works, Plans and Schedule of Works. Contractors are advised to carefully read all documentation.

### **1. Mandatory Requirements / Constraints**

As part of your tender response, you must confirm that you meet the mandatory requirements / constraints, if any, as set out in the Council’s specification forming part of this ITT. A failure to comply with one or more mandatory requirements or constraints shall entitle the Council to reject a tender response in full.

### **2. Third party verifications**

Your tender response is submitted on the basis that you consent to the Council

carrying out all necessary actions to verify the information that you have provided, and the analysis of your tender response being undertaken by one or more third parties commissioned by the Council for such purposes.

### **3. Potential suppliers to make their own enquires**

You are responsible for analysing and reviewing all information provided to you as part of this Procurement Process and for forming your own opinions and seeking advice as you consider appropriate. You should notify the Council promptly of any perceived ambiguity, inconsistency or omission in this ITT and/or any in of its associated documents and/or in any information provided to you as part of this Procurement Process.

### **4. Amendments to the ITT**

At any time prior to the Tender Response Deadline, the Council may amend the ITT. Any such amendment shall be issued to all potential suppliers, and if appropriate to ensure potential suppliers have reasonable time in which to take such amendment into account, the Tender Response Deadline shall, at the discretion of the Council, be extended. Your tender response must comply with any amendment made by the Council in accordance with this paragraph or it may be rejected. **No alteration to the text of the Form of Tender is to be made by the Contractor tendering. Should any alteration, amendment, note or addition be made, the same will not be recognised and the reading of the printed Schedule will be adhered to.**

### **5. Format of tender response submission**

Tender responses must comprise the relevant documents specified by the Council completed in all areas and in the format as detailed by the Council (in the Supplier Response). Any documents requested by the Council must be completed in full. It is, therefore, important that you read the ITT carefully before completing and submitting your tender response.

### **6. Tender costs**

- i. You are responsible for obtaining all information necessary for preparation of your tender response and for all costs and expenses incurred in preparation of the tender response. Subject to the "Liability" Tender Condition below, you

accept by your participation in this procurement, including without limitation the submission of a tender response that you will not be entitled to claim from the Council any costs, expenses or liabilities that you may incur in tendering for this procurement irrespective of whether or not your tender response is successful.

- ii. The prices to be included in the Form of Tender are to be the full inclusive value of the work described, including all profit, costs and expenses, and all general risks, liabilities and obligations, but EXCLUDING VAT (if applicable)
- iii. A price shall be inserted against each item on the Form of Tender for each element of the contract tendered for.
- iv. Your “Overall Price” (as calculated in accordance with requirements of the Pricing Approach for the services) will be evaluated by the full Council.
- v. Prices must not be subject to any pricing assumptions, qualifications or indexation not provided for explicitly by the Council as part of the pricing approach. In the event that any prices are expressed as being subject to any pricing assumptions, qualifications or indexation not provided for by the Council as part of the pricing approach, the Council may reject the full tender response at this point. The Council may also reject any tender response where the Overall Price for the goods and/or services is considered by the Council to be abnormally low following the relevant processes set out under the EU procurement rules.

## **7. Modifications to tender response documents once submitted**

You may modify your tender response prior to the Tender Response Deadline by giving written notice to the Clerk to the Council. Any modification should be clear and submitted as a complete new tender response in accordance with Annex 3 (Supplier Response) and these Tender Conditions.

## **8. Rejection of tender responses or other documents**

A tender response or any other document requested by the Council may be rejected which:

- contains gaps, omissions, misrepresentations, errors, uncompleted sections, or changes to the format of the tender documentation provided;
- contains hand written amendments which have not been initialled by the authorised

signatory;

- does not reflect and confirm full and unconditional compliance with all of the documents issued by the Council forming part of the ITT;
  - contains any caveats or any other statements or assumptions qualifying the tender response that are not capable of evaluation in accordance with the evaluation model or requiring changes to any documents issued by the Council in any way;
  - is not submitted in a manner consistent with the provisions set out in this ITT;
  - is received after the Tender Response Deadline.
9. **Disqualification** – If you breach these Tender Conditions, if there are any errors, omissions or material adverse changes relating to any information supplied by you at any stage in this Procurement Process, if any other circumstances set out in this ITT, and/or in any supporting documents, entitling the Council to reject a tender response apply and/or if you or your appointed advisers attempt:
- to inappropriately influence this Procurement Process;
  - to fix or set the price for goods or services;
  - to enter into an arrangement with any other party that such party shall refrain from submitting a tender response;
  - to enter into any arrangement with any other party (other than another party that forms part of your consortium bid or is your proposed sub-contractor) as to the prices submitted;
  - to collude in any other way;
  - to engage in direct or indirect bribery or canvassing by you or your appointed advisers in relation to this Procurement Process; or
  - to obtain information from any of the Employees, Councillors or advisors of the Council concerning this Procurement Process (other than as set out in these Tender Conditions) or from another potential supplier or another tender response,

The Council shall be entitled to reject your tender response in full and to disqualify you from this Procurement Process.

## C. DETAILED CONTRACT SPECIFICATION

---

### Grassed areas

---

- 3.1 Cut the Playing Fields grass, including embankment up to the castle slide.
- 3.2 Cuts are to be carried out in fair weather where possible and re scheduled where possible to ensure a high standard of cut.
- 3.3 Cuts are to be carried out where possible during quieter periods such as midweek, when the Park is likely to be quiet (try to avoid busy periods such as weekends).
- 3.4 Height of cut to be agreed with the contractor.
- 3.5 Max cuts 16 per year, to be scheduled by the contractor.
- 3.6 All rubbish is to be cleared from the area prior to cutting.
- 3.7 Strim around the play park equipment (this includes under the web climbing frame), taking care not to damage the equipment. Extreme care should be taken when going around the equipment, especially the wooden equipment.
- 3.8 Strim edges of field at the top end of the Playing Fields where the play equipment is. This top area is to be kept short and free of nettles as it is in close proximity to the play equipment.
- 3.9 Necessary care should be taken to avoid injury or damage to surrounding people and property and adequate protection must be worn whilst carrying out grounds work.
- 3.10 Any damaging pests and/or disease that would be detrimental to the grass surface are to be reported by the contractor to the Council, as soon as possible.

### Litter picking & emptying of bins

---

Check the bins and empty when required into the large bin located at Thornborough Hall.

While checking to bins pick up any litter on the Playing Fields.

The Council will pay 1 hour a week during term time for this task and 2 hours a week during school holidays.

### Mower Maintenance

---

The mower needs taking for an annual service at Simon Winstanley's, Leyburn and collecting when complete. Please quote an annual cost for this including any other time for maintenance checks need. This is to be invoiced to the Council annually.

---

### Litter picking & emptying of bins

---

Term time- - the Council will pay 1 hour a week for 42 weeks.

School holidays- The Council will pay 2 hours a week for 10 weeks.

### Maintenance of the mower

---

The Council will pay an annual amount to the contractor to cover time to take the mower for its annual service and any other time to maintain the mower.
