A resident raised concerns over the lack of local public transport.

Cllr Sedgewick also informed the Council that the following donations will be made out of the locality budget- £300 to Leyburn Community Library for magazine subscriptions & £600 for the improving green spaces project.

In total in the reporting period, for the area covered by Leyburn, 133 calls were received covering a variety of incidents.

Once again the door to door sellers are visiting the area, claiming to be selling household goods as part of their probation or to gain points towards an apprenticeship scheme. Do not feel that you are helping them in anyway, politely refuse, close the door and report the incident to North Yorkshire Police, providing a description and if possible any vehicle details.
