#### 23.128 PUBLIC REPRESENTATIONS-

Thanks were given to Gillian Aitken and the volunteers who have planted the wild flowers and to NY Council for repairing the fence around the recycling centre.

Concerns were raised over the increasing number of empty buildings in Leyburn, which are in disrepair. The Council share these concerns, however these buildings are privately owned therefore the maintenance of the buildings is out of our control.

Residents reported that the cash machine has not been working for a week, domestic waste been put in the litter bin in the rear car park, blue trade waste bins obstructing the pavement outside the Quaker House, Grove Square and concerns over the obstruction of paths around the Market Square by tables, chairs and shop goods.

The Council discussed the application and resolved that they cannot currently make comment on the application, as the plans are factually incorrect they don't relate to the situation as it stands. The maps show that the Slurry store is in the middle of the location highlighted as a new building on previous granted planning application 18/00455/FULL. Please can NY Council clarify and revise plans to show the true location of buildings and store. Concerns were raised over the current large soil heaps; these must be removed once the development is completed.

Action; Cllr Sedgewick will take comments back to Planning Committee and will request a site visit.

- **a. Traffic Regulation Order (TRO)-** The Council discussed the proposal and would support the endorsement of the following restrictions-5am-9.30am loading bay only & a maximum stay of 30 minutes parking when the bay is not being used for loading.
- **b. Vehicle Activated Sign (VAS Sign)** The Council discussed the initiative put forward by Cllr Sedgewick and the residents of Moor Road to

purchase a VAS. The sign will be funded by grants given from Yorvik Homes and the North Yorkshire Locality Budget. The Council resolved that they would accept responsibility for the VAS sign (maintenance, insurance and moving the sign).

Action: Clerk to enquire about the cost of adding this to our insurance policy. Cllr Sedgewick to go back to NY Highways to clarify the request from residents to have 3 locations for the sign.

- **c. 30MPH Speed Limit Extension** The Council accept and support the extension of the speed limit on Moor Road.
- **d. Planned Highways Maintenance** The Council discussed concerns raised by residents with Cllr Sedgewick. These concerns have been raised with NY Highways and unfortunately this work cannot be rescheduled. Full access will be available to all businesses and NY Highways understood the councils concerns and need for improved consultation in the future.
